Rats exposed to a 5.3 mg/L dust aerosol for 4-hr resulted in effects generally expected with high concentrations of dust aerosols made of relatively dense particles. Higher lung weight and atelectasis persisted after the 14-day recovery period. There were no reports of lethality or any significant

clinical observations. There was however an acute

inflammatory response with evidence of recovery after 14-days. The presence of particulate matter with indication of partial clearance from the lung after the 14-day recovery period was noted. These effects would not be expected during normal operating conditions when using this substance.


